

**A RESOLUTION AUTHORIZING THE ADVERTISEMENT
FOR RECEIPT OF BIDS FOR
SEWER AND STORMWATER COLLECTION SYSTEM
MAINTENANCE AND REPAIR SERVICES
UNDER THE DEPARTMENT OF PUBLIC WORKS SEWER DIVISION**

WHEREAS, the Department of Public Works Sewer Division is responsible for providing maintenance and repairs to the municipal sanitary system; and

WHEREAS, in May of 2019, pursuant to Resolution 138-5.19, the Township authorized an agreement with J. Fletcher Creamer & Son, Inc. to provide Sewer and Stormwater Collection System Maintenance and Repair Services, under contract BID19007, with an amended not-to-exceed amount of \$250,000.00; and

WHEREAS, with the current agreement expiring the end of April 2023, it is the Acting Director's recommendation to continue to have a company engaged in providing for Sewer and Stormwater Collection System Maintenance and Repair Services; and

WHEREAS, the aggregate of said goods and services requested is anticipated to exceed the current bid threshold, and is therefore required to be bid under a formal process pursuant to Local Public Contracts Law N.J.S.A. 40A:11-3 et seq.; and

WHEREAS, for repairs that are capital and/or urgent in nature contracted items will be funded from existing Sewer Capital Ordinance(s) and maintenance and routine repairs will be funded from the Sewer Operating Budget.

NOW, THEREFORE, BE IT RESOLVED, on this 20th day of March, 2023 that the Township Council of the Township of North Brunswick does hereby authorize the advertisement for the receipt of bids for the following specification:
