A RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK AUTHORIZING AN AMENDMENT TO CONTRACT BID20004 WITH SANITATION EQUIPMENT CORP. FOR REPLACEMENT PARTS FOR AUTOMATED REFUSE TRUCK BODIES UNDER THE DEPARTMENT OF PUBLIC WORKS

WHEREAS, the Department of Public Works - Vehicle Maintenance Division is responsible for providing maintenance and repairs within the municipal fleet; and

WHEREAS, included within the Sanitation Division's fleet are vehicles with automated truck bodies that require specialized parts; and

WHEREAS, on February 18, 2020, the Township Council of the Township of North Brunswick approved Resolution 84-2.20 authorizing the advertisement for receipt of bids for Labrie OEM replacement parts for automated refuse truck bodies; and

WHEREAS, in April of 2020, pursuant to Resolution #129-4.20, the Township authorized a contract with Sanitation Equipment Corp. (with offices at 80 Furler Street, Totowa, NJ 07512) to provide the replacement of OEM Labrie parts on the automated refuse truck bodies, in an amount not-to-exceed \$50,000.00, with a two-year term beginning May 1, 2020 and ending April 30, 2022, and included the option for two additional one-year extensions; and

WHERES, in May of 2022, pursuant to Resolution #172-5.22, the Township authorized an amendment to the contract with Sanitation Equipment Corp. extending the contract term from May 1, 2022 – April 30, 2023, and an increased authorization amount of not-to-exceed \$75,000.00; and

WHEREAS, Steven Bloyed, Acting Director of the Department of Public Works, determined there is a continued need to have a third-party company available to provide the replacement of OEM Labrie parts on the automated refuse truck bodies and recommends authorizing another one-year extension with no increase in the current authorization amount of not-to-exceed \$75,000.00; and

WHEREAS, the Chief Financial Officer certifies that funds in the amount of \$3,000.00 are available in FY2023 MVM Operating 3-01-26-315-000-230 for services ending June 30, 2023 and the balance shall be certified contingent upon the appropriation of funding in future fiscal years.

NOW, THEREFORE, BE IT RESOLVED, on this 15th day of May 2023 that the Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute and the Township Clerk to witness an amendment to the agreement with Sanitation

Equipment Corp. extending the contract term by one year, from May 1, 2023 – April 30, 2024, for the replacement of OEM Labrie parts on the automated refuse truck bodies, with no increase in the current authorization amount of not-to-exceed \$75,000.00, pursuant to contract BID20004.
