

**A RESOLUTION OF THE TOWNSHIP COUNCIL OF  
THE TOWNSHIP OF NORTH BRUNSWICK CONFIRMING THE APPOINTMENT OF  
LUCIANA WHEELER AS DEPUTY COURT ADMINISTRATOR FOR  
THE TOWNSHIP OF NORTH BRUNSWICK**

**WHEREAS**, after nearly 20 years of service to the Township of North Brunswick, Sheral Rossmann, the Certified Municipal Court Administrator of the North Brunswick Municipal Court retired as of December 31, 2020; and

**WHEREAS**, on January 1, 2021, pursuant to legislation N.J.S.A.2B:11-10.b et seq. and authorized under Resolution 28-1.21, the Council consented to the Mayor's appointment of *Deputy Court Administrator* Kim Molnar to serve as Acting Court Administrator for the Municipal Court of the Township of North Brunswick, until such time as a Court Administrator was appointed; and

**WHEREAS**, proper notice for qualified candidates to respond to the position were duly advertised and Township Officials worked with the Superior Court of New Jersey Municipal Division Manager for the Middlesex Vicinage on the interview and selection process; and

**WHEREAS**, after the conclusion of interviews by the evaluation panel, the Mayor made a recommendation to appoint *Deputy Court Administrator* Kim Molnar to serve as Court Administrator and received support from the 2021 Presiding Judge Christine Heitmann and Middlesex Vicinage Division Manager Tiffany Leverett; and

**WHEREAS**, on February 1, 2021, pursuant to legislation N.J.S.A. 2B:11-10.a et seq. and authorized under Resolution 68-2.01, the Council consented to the Mayor's appointment of *Deputy Court Administrator* Kim Molnar to serve as Court Administrator for the Municipal Court of the Township of North Brunswick, effective February 1, 2021; and

**WHEREAS**, Kim Molnar's appointment to Court Administrator created a vacancy for the position *Deputy Court Administrator*, which the position was then duly noticed in May of 2021 seeking qualified candidates; and

**WHEREAS**, in July of 2021, pursuant to Resolution 193-2.21, Lauren Colletti was appointed to serve as *Deputy Court Administrator* for the Municipal Court of the Township of North Brunswick; and

**WHEREAS**, in August of 2022, following the resignation of Lauren Colletti, Kelly Wolff was appointed to serve as *Deputy Court Administrator* for the Municipal Court of the Township of North Brunswick; and

**WHEREAS**, in March of 2023, the Township received a letter of resignation from Kelly Wolff creating a vacancy for the position *Deputy Court Administrator*, which was then duly noticed in April of 2023 seeking qualified candidates; and

**WHEREAS**, in April of 2023, Municipal Officials worked with the Superior Court of New Jersey Municipal Division Manager for the Middlesex Vicinage on the interview and selection process; and

**WHEREAS**, after the conclusion of interviews by the evaluation panel, the Mayor made a recommendation to appoint Luciana Wheeler serve as *Deputy Court Administrator* and has received support from the current Presiding Judge Christine Heitmann and Division Manager Laura Schweitzer; and

**WHEREAS**, the Township Council wishes to consent to the appointment of Luciana Wheeler to serve as *Deputy Court Administrator* for the Municipal Court of the Township of North Brunswick.

**NOW, THEREFORE, BE IT RESOLVED** on this 30<sup>th</sup> day of May 2023, the Township Council of the Township of North Brunswick, County of Middlesex, and State of New Jersey, be and the same hereby consents to the appointment of Luciana Wheeler to serve as *Deputy Court Administrator* for the Municipal Court of the Township of North Brunswick, effective June 1, 2023.
