A RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK AUTHORIZING AN AMENDMENT TO CONTRACT BID22002 WITH IPL, NORTH AMERICA INC. FOR (UP TO 3,000) 95 GALLON ROLL-OUT CONTAINERS UNDER THE DEPARTMENT OF PUBLIC WORKS

WHEREAS, the Department of Public Works is responsible for the collection of refuse and recycling generated by residents and various approved entities located within the municipality; and

WHEREAS, on May 17, 2021 the Township Council approved Resolution 149-5.21 authorizing advertisement for receipt of bids for (UP TO 3,000) 95-gallon roll-out containers, BID21002; and

WHEREAS, in August of 2021, pursuant to Resolution #229-8.21, the Township authorized a contract with IPL North America Inc. (140, rue Commerciale St-Damien-de-Buckland, QC G0O 2Y0 Canada) to provide (UP TO 3,000) 95 Gallon Roll-out Containers in the amount of \$179,205.00 with a unit cost of \$58.92 for year one (7/1/2021 - 6/30/2022) and a unit price of \$60.55 for year two (7/1/2022 - 6/30/2023) with a two-year term (May 1, 2019 – April 30, 2021) with a one (1) optional 2 year extension; and

WHEREAS, Steven Bloyed, Acting Director of the Department of Public Works, determined there is a continued need for 95 Gallon Container carts and recommends authorizing a two-year extension with a unit cost of \$59.67/cart and no increase in the current authorization amount of not-to-exceed \$179,205.00; and

NOW, THEREFORE, BE IT RESOLVED, on this 30th day of May 2023 that the Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute and the Township Clerk to witness an amendment to the agreement with IPL North America Inc. extending the contract term by two years, from July 1, 2023 – June 30, 2025, to provide (UP TO 3,000) 95 Gallon Roll-out Containers at a unit cost of \$59.67/cart, with no increase in the current authorization amount of not-to-exceed \$179,205.00, pursuant to contract BID21002.
