

RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK
 AUTHORIZING THE APPLICATION AND ACCEPTANCE OF A FEDERAL GRANT
 FROM THE STATE OF NEW JERSEY DEPARTMENT OF LAW AND PUBLIC SAFETY,
 DIVISION OF HIGHWAY TRAFFIC SAFETY

WHEREAS, the Township of North Brunswick desires to apply for and accept the “HTS Mobilization 2023 Click It or Ticket” Statewide Seatbelt Enforcement Mobilization reimbursement funds in the mount of \$7,000.00 to provide enforcement of the Seatbelt and Child/Adult Passenger laws for all of those who travel through the Township of North Brunswick; and

WHEREAS, the State of New Jersey will participate in the nationwide Click It or Ticket safety belt mobilization from May 22, 2023 through June 4, 2023 in an effort to raise awareness and increase safety belt usage through a combination of enforcement and education; and

WHEREAS, it would be in the best interest of North Brunswick Township to accept said monies, with no matching funds required. The maximum project overtime rate is \$70.00 per hour. Officers paid more than \$70.00 per hour will be reimbursed at \$70.00 per hour by the grant with the municipality covering the remainder of the rate;

NOW THEREFORE, BE IT RESOLVED, on this ___ day of May, 2023, by the Township Council of the Township of North Brunswick, County of Middlesex, and State of New Jersey, that the Mayor or his designee are authorized to execute and sign any and all documents in order to effectuate the receipt of federal grant monies between the North Brunswick Township and the State of New Jersey, Division of Highway Traffic Safety for the “Click It or Ticket Statewide Seatbelt Enforcement Mobilization” grant in the amount of \$7,000.00.
