

**A RESOLUTION OF THE TOWNSHIP COUNCIL OF NORTH BRUNSWICK
CONFIRMING THE REAPPOINTMENT OF JOSEPH LOMBARDI, ESQ.
AS MUNICIPAL COURT JUDGE FOR THE TOWNSHIP OF NORTH BRUNSWICK**

WHEREAS, in May of 2014, in addition to Judge Heitmann, the Mayor made a recommendation to appoint William D. Feingold, Esq., as a second Municipal Court Judge and the Township Council gave its advice and consent to such appointment, with a term of three (3) years ending on May 19, 2017 (pursuant to resolution 164-5.14); and

WHEREAS, in November of 2016 Judge Feingold stepped down, creating a vacancy for the second Municipal Court Judge position; and

WHEREAS, in December of 2016 Joseph Lombardi, Esq. was appointed as Municipal Court Judge, to serve the unexpired term of Judge Feingold, ending May 19, 2017 (pursuant to Resolution 300-12.16);

WHEREAS, in 2017 Judge Joseph Lombardi was reappointed to serve as a Municipal Court Judge for the Municipal Court of the Township of North Brunswick, beginning May 21, 2017 and ending May 20, 2020 (pursuant to Resolution 165-6.17); and

WHEREAS, in 2022 Judge Joseph Lombardi was reappointed to serve as a Municipal Court Judge for the Municipal Court of the Township of North Brunswick, with a retroactive date of May 21, 2020 and ending May 20, 2023 (pursuant to Resolution 54-1.22); and

WHEREAS, Judge Lombardi has served with professionalism and distinction during his term and Mayor Womack wishes to nominate him for reappointment as Municipal Court Judge for another three-year term, retroactive effective May 21, 2023 and ending May 20, 2026; and

WHEREAS, the Township Council wishes to consent to the reappointment of Joseph Lombardi, Esq. as a Municipal Court Judge for the Municipal Court of the Township of North Brunswick.

NOW, THEREFORE, BE IT RESOLVED on this 30th day of May 2023, pursuant to N.J.S.A.2B:12-4, the Township Council of the Township of North Brunswick, County of Middlesex, and State of New Jersey, confirms the Mayor's appointment of Joseph Lombardi, Esq. to serve as Municipal Court Judge, with a retroactive effective date of May 21, 2023; and

BE IT FURTHER RESOLVED Township Council hereby gives its advice and consent to such appointment for another term of three (3) years ending on May 20, 2026 or until such time as a successor is appointed and qualified.
