## FOR THE SUPPLY AND INSTALLATION OF FLOORING MATERIAL AT THE MUNICIPAL COMPLEX

**WHEREAS**, Hurricane Ida impacted New Jersey on Wednesday, September 1, 2021, bringing severe weather conditions including strong winds and heavy and sustained rainfall in some areas; and

WHEREAS, during the event, a significant amount of water penetrated the Municipal Complex, causing major damage to the basement and sections of the first floor, including the Police Department; and

WHEREAS, in March of 2023, pursuant to Resolution 98-3.23, the Township engaged Servpro Disaster Recovery Services to take over the remediation and restoration efforts at the Municipal Complex; and

WHEREAS, it was noted during the transition from the former contractor, that the flooring material listed within the insurance claim had never been ordered by Rapid Recovery, that listed the vendor The Gillespie Group; and

**WHEREAS**, the week of March 20<sup>th</sup>, municipal officials met with representatives for The Gillespie Group to review the scope of work and materials needed, with Servpro Disaster Recovery Services performing any demolition and removal of flooring material; and

**WHEREAS**, the Township of North Brunswick is currently a member of the Educational Services Commission of New Jersey State approved Co-op #65MCESCCPS; and

**WHEREAS,** The Gillespie Group (with offices at 5 Chris Court, Suite G, Dayton, New Jersey 08810) is an approved vendor under Educational Services Commission of New Jersey Co-Op Bid #19/20-05 for Carpeting and Flooring; and
