

**AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 227  
“PARKING FOR THE HANDICAPPED”  
OF THE CODE OF THE TOWNSHIP OF NORTH BRUNSWICK**

**BE IT ORDAINED**, by the Township Council of the Township of North Brunswick, that Chapter 227-8.1(M), Schedule A: Residential Handicapped Parking Zones, be and is hereby amended and supplemented as follows:

**The following handicapped parking resident zones are established:**

Being the area shown on the sketch attached hereto as Exhibit F, along Hollywood Street, for and only on behalf of Karen Nicklaus, residing at 622 Livingston Avenue, North Brunswick, New Jersey.

**BE IT FURTHER ORDAINED**, the applicant granted restricted parking zones for handicapped residents by this Ordinance shall comply strictly with requirements of Section 227-8.1 of Chapter 227 of the Township of North Brunswick.

**BE IT FURTHER ORDAINED**, any ordinances or parts thereof in conflict with the provisions of this Ordinance are repealed to the extent of such conflict.

**BE IT FURTHER ORDAINED**, this Ordinance shall take effect upon passage and publication in accordance with applicable law.
