

**AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 334-54
VEHICLES AND TRAFFIC
OF THE CODE OF THE TOWNSHIP OF NORTH BRUNSWICK**

WHEREAS, the Director of Community Development, in conjunction with the Chief of Police and the Traffic Safety Bureau, has determined that regulations for excluding trucks over designated weights from certain streets are not properly inclusive; and

WHEREAS, in accordance with the provisions of §334-10, vehicles over certain registered gross weights are excluded from the streets or parts of streets described herein except for the pickup and delivery of materials on such streets.

NOW, THEREFORE, BE IT ORDAINED, by the Township Council of the Township of North Brunswick, that the schedule Chapter 334-54, Vehicles and Traffic, Schedule XXIV: Trucks Over Designated Weight, is hereby amended as follows:

§ 334-54 Schedule XXIV: Trucks Over Designated Weight.

In accordance with the provisions of §334-10, vehicles over the registered gross weight are hereby excluded from the streets or parts of streets described herein except for the pickup and delivery of materials on such streets.

Name of Street	Weight	Location
Linwood Place	4 tons	Ridgewood Avenue to Hermann Road

BE IT FURTHER ORDAINED, if any section, paragraph, subsection, clause or provision of this Ordinance shall be adjudged by the courts to be invalid, such adjudication shall apply only to the section paragraph, subsection, clause or provision so adjudicated, and the remainder of the Ordinance shall be deemed valid and effective.

BE IT FURTHER ORDAINED, any ordinances or parts thereof in conflict with the provisions of this Ordinance are repealed to the extent of such conflict.

BE IT FURTHER ORDAINED, this Ordinance shall take effect upon passage and publication in accordance with applicable law.

TITLE

This Ordinance shall be known as may be cited as the Ordinance Amending and Supplementing Chapter 334-54 Vehicles and Traffic of the Code of the Township of North Brunswick
