

**A RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK  
AUTHORIZING THE ADVERTISEMENT  
FOR THE RECEIPT OF BIDS FOR THE  
MAINTENANCE AND REPAIR OF TRAFFIC LIGHT SIGNALS  
UNDER THE DEPARTMENT OF PUBLIC WORKS**

**WHEREAS**, Traffic signals exist to control the flow of traffic to increase safety, manage traffic and travel times, and provide direction for drivers; and

**WHEREAS**, it is hereby the Acting Director's recommendation to the Mayor and Council to solicit bids for the preventative maintenance and repair of the traffic signals within the Township of North Brunswick; and

**WHEREAS**, pursuant to N.J.S.A. 40A:11-6 et seq. under the Local Public Contract Law, any contract may be negotiated or awarded for a contracting unit without public advertising for bids and bidding therefor, notwithstanding that the contract price will exceed the bid threshold, when an emergency affecting the public health, safety or welfare requires the immediate delivery of goods or the performance of services; and

**WHEREAS**, the goods and services price is anticipated to exceed the current bid threshold, and is therefore required to be bid under a formal process pursuant to Public Contracts Law N.J.S.A. 40A:11-3 et seq.; and

**NOW, THEREFORE, BE IT RESOLVED**, on this 5<sup>th</sup> day of September 2023, that the Township Council of the Township of North Brunswick does hereby authorize the advertisement for the receipt of bids for the following specification:
