# A RESOLUTION OF THE TOWNSHIP COUNCIL OF NORTH BRUNSWICK AUTHORIZING AN AMENDMENT TO THE 2023 AGREEMENT WITH DAVID P. LONSKI OF THE FIRM SHAMY, SHIPERS AND LONSKI, PC TO SERVE AS MUNICIPAL PROSECUTOR

**WHEREAS,** Resolution 7-1.23 approved by the Township Council authorized David P. Lonski (or his designee) of the firm Shamy, Shipers & Lonski, PC (334 Milltown Road, East Brunswick, NJ 08816) to serve in the position of Municipal Prosecutor for calendar year 2023, and was awarded under a fair and open contract process, pursuant to the provisions of N.J.S.A. 19:44A-20.1 et seq.; and

**WHEREAS,** compensation for said services was set at a rate of \$275.00 per session for regularly scheduled and special sessions, and reimbursable expenses in an amount not-to-exceed \$56,000.00 for calendar year 2023; and

WHEREAS, the purpose of a "plea by mail" in New Jersey is to allow individuals to contest certain offenses including traffic tickets without having to appear in person (or a scheduled virtual session) with the municipal court; and

**WHEREAS,** under the plea by mail process, eligible traffic tickets are processed by the municipal prosecutor that reviews the case and provides a recommendation; and

WHEREAS, under the current agreement for the Municipal Prosecutor, compensation for said services is set at a rate of \$275.00 per session (virtual or in person) for regularly scheduled and special sessions, not accounting for the plea by mail case load; and

WHEREAS, with an increase in plea by mail requests, it has become necessary to increase the authorized amount per session from \$275.00 to \$350.00 to account for processing time with the added volume of plea by mail cases.

**NOW, THEREFORE, BE IT RESOLVED** on this 5<sup>th</sup> day of September 2023, that the Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute and the Township Clerk to witness an amendment to the agreement with David P. Lonski (or his designee) of the firm Shamy, Shipers & Lonski, PC, serving as Municipal Prosecutor for calendar year 2023, amending the amount per session from \$275.00 to \$350.00 and increase the authorized amount from \$56,000.00 to \$70,000.00; and

**BE IT FURTHER RESOLVED** notice of this action shall be published in the Home News & Tribune as required by law within 10 (ten) days after its passage.

This form can only be used to plead not guilty or guilty in certain traffic (including parking) cases or to plead guilty in certain non-traffic cases. See court rules 7:12-3 and 7:6-3. For example, you cannot use this form to plead in cases involving domestic violence, where the defendant's identity is at issue, in a traffic accident with personal injury, or where the penalty involves a mandatory license suspension. Please contact the Municipal Court for any questions on whether your charge is eligible.

- You have the right to a reasonable postponement. You have the right to be informed of your charges and the penalties you face for those charges. You have the right to retain an attorney or apply for a public defender if you cannot afford an attorney. You have the right to remain silent. You have the right to contest your case at trial, including the right to be present at the trial, to cross-examine any witnesses, and to call witnesses to testify for your defense.
- If you are not a United States (U.S.) citizen and if you plead guilty to or are convicted of certain offenses heard in the Municipal Court, including some motor vehicle offenses, it may result in your being deported from the U.S., may prevent you from being re-admitted to the U.S. if you leave voluntarily, or it may prevent you from ever becoming a naturalized U.S. citizen. You have the right to seek advice from an attorney about the effect a guilty plea will have on your immigration status.
- If you plead guilty or the judge finds you guilty of an offense other than parking, a record of the conviction may be sent to the NJ Motor Vehicle Commission and, if your license was not issued by NJ, to the motor vehicle agency of the state that issued your driver's license.

#### Plea by Mail Form

• The judgment of the court will be sent to you electronically or by ordinary mail at the above address and if you plead guilty or are found guilty you must pay all fines, penalties, and costs imposed by the court. You have the right to appeal within 20 days of the date of the decision or sentence. Information on how to appeal the Municipal Court's decision may be obtained from the Municipal Court or the Judiciary's website at <a href="https://www.njcourts.gov">www.njcourts.gov</a>.

**If you plead "Not Guilty,"** the Municipal Court judge will hear the testimony of the complaining witness or other witnesses, review any facts you choose to present in Section 3 in your defense, and decide the case based on the testimony and facts presented.

If you plead "Guilty," the Municipal Court judge will consider any facts you choose to present in Section 3 to explain what happened before imposing any penalty against you.

Before determining the penalty, the Municipal Court judge may consider comments from the complaining witness, other witnesses, or the prosecutor.
