

**A RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK
AUTHORIZING A CONTRACT WITH
PELLEGRINO CHEVROLET
FOR THE PURCHASE OF ONE MASON DUMP TRUCK
UNDER THE DEPARTMENT OF PUBLIC WORKS**

WHEREAS, it was previously determined there is a need to replace an existing vehicle within the Department of Public Works (2009 Chevrolet 3500 Utility Truck - Vehicle No. 818) that has exceeded its useful life; and

WHEREAS, the Township of North Brunswick is currently a member of the Educational Services Commission of New Jersey State approved Co-op #65MCESCCPS; and

WHEREAS, Pelligrino Chevrolet (with offices at 1000 Gateway Blvd. Westville, NJ 08093) is an approved vendor under Educational Services Commission of New Jersey Co-Op Bid #23/24-04 for Class 4-8 Trucks; and

WHEREAS, Pelligrino Chevrolet under Bid #23/24-04 has provided a proposal for one (1) 2023 Chevrolet 3500HD Silverado with a Mason Dump body at a cost of \$73,317.00; and

WHEREAS, funding for this purchase was included in the FY2024 Capital Ordinance 23-11; and

NOW THEREFORE BE IT RESOLVED, that the Township Council of the Township of North Brunswick does hereby authorize the award of a contract to Pelligrino Chevrolet in the amount of \$73,317.00 for the purchase of one (1) 2023 Chevrolet 3500HD Silverado with a Mason Dump body; and

BE IT FURTHER RESOLVED, that the Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute and the Township Clerk to witness an agreement with Pelligrino Chevrolet in accordance with the previously approved Educational Services Commission of New Jersey Co-Op Bid #20/21-55.
