

**A RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK
AUTHORIZING AN AMENDMENT TO CONTRACT BID19012
WITH NATIONAL WATER MAIN CLEANING CO. FOR
SEWER JET VAC SERVICES**

WHEREAS, the Department of Public Works Sewer Division provides for maintenance and repairs to the municipal wastewater distribution system which includes various pipe lines, manholes and pump stations; and

WHEREAS, in February of 2020, pursuant to Resolution #71-2.20, the Township authorized a contract with National Water Main Cleaning Co. (1806 Newark Turnpike Kearney, NJ 07032) to provide Sewer Jet Vac services, on an as-needed basis, in the amount \$50,000.00 for goods and services identified as items 1-15, with a two-year term beginning February 1, 2020 and ending January 31, 2022, and included the option for two additional one-year extensions; and

WHEREAS, in June of 2021, pursuant to Resolution 1#91-6.21, the Township authorized an amendment to increase the authorization amount from \$50,000.00 to \$75,000.00; and

WHEREAS, in January of 2022, pursuant to Resolution #50-1.22, the Township authorized an amendment to the contract with National Water Main Cleaning Co. (to provide Sewer Jet Vac services, on an as-needed basis, for goods and services identified as items 1-15, with a one-year extension beginning February 1, 2022 and ending January 31, 2023 and a 2.45% price increase for goods and services identified as items 1-15 with a not-to-exceed amount of 95,000.00; and

WHEREAS, in February of 2023, pursuant to Resolution #068-2.23, the Township authorized an amendment to the contract with National Water Main Cleaning Co. to provide Sewer Jet Vac services, on an as-needed basis, for goods and services identified as items 1-15, with another one-year extension beginning February 1, 2023 and ending January 31, 2024 and a 4.4% price increase for goods and services identified as items 1-15, increasing the authorization amount to not-to-exceed \$120,000.00; and

WHEREAS, in May of 2023, pursuant to Resolution #179-5.23, the Township authorized an amendment to the contract with National Water Main Cleaning Co. to provide Sewer Jet Vac services, on an as-needed basis, increasing the authorization amount to not-to-exceed \$150,000.00; and

WHEREAS, based on the continuing preventative maintenance and cleaning of the wet wells, the Director recommends increasing the current authorization amount from \$150,000.00 to \$175,000.00, a net increase of \$25,000.00; and

WHEREAS, the Chief Financial Officer has certified that \$25,000.00 is available for this purpose in FY2023 Sewer Operating – Maintenance and Repair Account 4-07-55-502-000-183 for services ending June 30, 2024 and the balance shall be certified upon the appropriation of funding in future fiscal years.

NOW, THEREFORE, BE IT RESOLVED, on this 6th day of November 2023 that the Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute and the Township Clerk to witness an amendment to the agreement with National Water Main Cleaning Co. for Sewer Jet Vac Services, increasing the current authorization amount from \$150,000.00 to \$175,000.00, a net increase of \$25,0000, pursuant to contract BID19012.
