PROCLAMATION

By Mayor and Council – Township of North Brunswick

WHEREAS, in 2023 approximately 288,300 men will be diagnosed with prostate cancer in the United States. Roughly 34,700 will die this year from the disease, about 3,500 more than 2020; and

WHEREAS, in New Jersey, an estimated 9,460 new cases of prostate cancer will be diagnosed and an estimated 730 deaths will occur in 2023; and

WHEREAS, men with a family history of prostate cancer are twice as likely to develop the disease; and

WHEREAS, Prostate cancer is the most commonly diagnosed cancer in American Men and the third leading cause of cancer death behind lung and colon cancer; and

WHEREAS, 1 in 8 men are diagnosed with prostate cancer in their lifetime and 1 in 6 African American men will develop prostate cancer in their lifetime. Overall, African American men are 1.7 times more likely to be diagnosed with - and 2.1 times more likely to die from - prostate cancer than white men; and


WHEREAS, Veterans who were exposed to herbicides like Agent Orange are at increased risk for developing prostate cancer, and are more likely to have an aggressive form of the disease; and


WHEREAS, education regarding prostate cancer and early detection strategies is critical to saving lives, preserving, and protecting our families; and


WHEREAS, if caught early prostate cancer has a five-year survival rate of nearly 100%. However, for late stage prostate cancer the five-year survival rate is 31%.

WHEREAS, all men are at risk for prostate cancer and we encourage the citizens of North Brunswick Township to increase the importance of prostate awareness and screenings.

NOW THEREFORE, WE the Mayor and Council of the Township of North Brunswick, **Do Hereby Proclaim**, September as Prostate Cancer Awareness Month and join the entire community in supporting early detection and working towards a cure.
