

**A RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK  
AUTHORIZING THE RECEIPT OF BIDS  
TO PURCHASE ONE (1) 8-INCH TRASH PUMP  
FOR THE MUNICIPAL PUMPING STATIONS**

**WHEREAS**, the Department of Public Works Sewer Division is responsible for providing maintenance and repairs to the municipal sanitary system; and

**WHEREAS**, two pumps are located in all of our pump stations, with the exception of Schmidt Lane which currently runs on one pump, and are used to move liquids such as wastewater, sewage, oil or floodwater; and

**WHEREAS**, the Sewer Department is in need of purchasing one (1) 8-inch trash pump that can be used at any pump station if need be to connect to bypass sanitary pipes that will feed directly into the Force mains; and

**WHEREAS**, it is the Acting Director's recommendation to the Governing Body to receive bids for one (1) 8-inch sewer trash pump; and

**WHEREAS**, funding for this item is available in existing Sewer Capital Ordinance 21-18; and

**WHEREAS**, the goods and services price is anticipated to exceed the current bid threshold, and is therefore required to be bid under a formal process pursuant to Public Contracts Law N.J.S.A. 40A:11-3 et seq.

**NOW, THEREFORE, BE IT RESOLVED**, on this 18<sup>th</sup> day of September 2023 that the Township Council of the Township of North Brunswick does hereby authorize advertisement for the receipt of bids for the following specification:
