

**A RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK
AUTHORIZING THE AWARD OF CONTRACT BID23010
TO PUMPING SERVICES, INC.
FOR THE PURCHASE ONE (1) 8-INCH TRASH PUMP
FOR THE MUNICIPAL PUMPING STATIONS**

WHEREAS, the Department of Public Works Sewer Division is responsible for providing maintenance and repairs to the municipal sanitary system; and

WHEREAS, two pumps are located in all of our pump stations, with the exception of Schmidt Lane which currently runs on one pump, and are used to move liquids such as wastewater, sewage, oil or floodwater; and

WHEREAS, the Sewer Department is in need of purchasing one (1) 8-inch trash pump that can be used at any pump station if need be to connect to bypass sanitary pipes that will feed directly into the Force mains; and

WHEREAS, funding for this item is available in existing Sewer Capital Ordinance 19-22; and

WHEREAS, on September 18, 2023, pursuant to Resolution #297-9.23, the Township Council authorized the advertisement for the receipt of bids for the purchase of one (1) 8-inch trash pump for use at the Municipal Pump Stations, BID23010; and

WHEREAS, on Thursday October 19, 2023, the Purchasing Agent received and the Municipal Clerk witnessed one (1) bid in response to BID23010 for the purchase of one (1) 8-inch trash pump; and

WHEREAS, the apparent lowest responsive bid was submitted by Pumping Services, Inc. (201 Lincoln Blvd. Middlesex, NJ 08846) in the amount of \$116,875.00 for the purchase of one (1) 8-inch trash pump; and

WHEREAS, Steven Bloyed, Director of Public Works, and the Sewer Department Supervisor reviewed the bid submitted by Pumping Services, Inc.. and recommends the award of the contract; and

WHEREAS, Township Attorney Ronald Gordon has reviewed the bid submitted by Pumping Services, Inc. and determined it to be responsive under the provisions of the Local Public Contracts Law (N.J.S.A. 40A: 11- 1 et seq.) and any provisions of the revised statutes of the State of New Jersey; and

NOW THEREFORE, BE IT RESOLVED, Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute and the Township Clerk to witness an agreement with Pumping Services, Inc. in the amount of \$116,875.00 for the purchase of one (1) 8-inch trash pump for use at the Municipal Pump Station, pursuant to Contract BID23010.
