**BE IT FURTHER RESOLVED**, that the Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute and the Township Clerk to witness an agreement with National Fence Systems, Inc in accordance with the previously approved Hunterdon County Cooperative Pricing Agreement Bid #HCEC-Cat/Ser-19-16.

- We propose to perform the following:
  - o Remove and replace 1180 linear feet of 4' high chain link wire. New wire to be 2"x6ga fused and bonded black vinyl coated chain link wire knuckled finish on top and bottom. Includes all new fence ties.
  - o Replace approx. 70 linear feet of existing damaged 1 5/8" top rail.
  - o Add 1 5/8" black bottom rail
  - o All existing posts to be reused and remain in place

- Materials plus 5% markup: \$28,473.98
  - Foreman at \$73/hr: \$4,672.00
- 2 Laborers at \$73/hr each: \$9,344.00
- Equipment plus 5% markup: \$2,798.21
  - TOTAL: \$45,288.19
