They will be asking all the Townships to adopt a resolution. Discussion continues between Councilman Andrews and Ms. Sheer.

Another nurse, did not state her name, speaks regarding the strike and the effect it is having on peoples well being and livelihood.

Jessica Kino (North Brunswick Resident) is also a nurse and speaks in support of resolution to support the nurses. She tells about her life as a nurse and the effect this is having on her and her family. Discussion continues between Councilman Andrews, Ms. Sher and Ms. Kino.

Catherine Hurt, Retired nurse speaks about her career as a nurse and asks if the Governing Body can support the nurses and adopt the resolution.

Tony Nastus addresses various concerns he has in regards to several properties in North Brunswick Township. Mr. Nastus continues to state various concerns he has regarding buses through residential neighborhoods for New Brunswick School, cars parked on Township roadways with commercial plates and businesses being run out of residential homes and other concerns previously stated. Discussion continues between Mr. Nastus and Director Hritz.
