NOW, THEREFORE, BE IT RESOLVED on this 20th day of November 2023, that the Township Council of the Township of North Brunswick does hereby confirm an agreement with MRC for the purchase and installation of playground equipment at Babbage Park, with a total cost of \$92,559.52 in accordance with ESCNJ contract 20/21-06.


