

**A RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK
CONFIRMING THE AWARD OF A CONTRACT TO MRC
FOR REPLACEMENT PLAYGROUND EQUIPMENT AT BABBAGE PARK**

WHEREAS, in July of 2023 pursuant to Resolution 233-6.23, the Township Council authorized the purchase of goods and services from various vendors approved under cooperative purchasing agreements; and,

WHEREAS, Marturano Recreation Co. (“MRC”) is an approved vendor under the Educational Services Commission of New Jersey (“ESCNJ”) cooperative purchasing agreement for playground equipment; and,

WHEREAS, MRC with offices in Spring Lake, New Jersey 07762, holds ESCNJ Contract 20/21-06 for playground equipment; and,

WHEREAS, at the request of the Township, MRC has provided a proposal dated October 17, 2023 totaling \$92,559.52 for the purchase and installation of playground equipment; and,

WHEREAS, funding for the playground equipment was included in the Fiscal Year 2024 Capital Budget.

NOW, THEREFORE, BE IT RESOLVED on this 20th day of November 2023, that the Township Council of the Township of North Brunswick does hereby confirm an agreement with MRC for the purchase and installation of playground equipment at Babbage Park, with a total cost of \$92,559.52 in accordance with ESCNJ contract 20/21-06.

Equipment shall be invoiced separately from other services and shall be payable in advance of those services and project completion. Retainage not accepted.

TAXES: State and local taxes, if applicable, will be added at time of invoicing unless a tax exempt certificate is provided at the time of order entry.

FREIGHT/SHIPMENT: Freight charges: Prepaid and added at time of invoicing. Shipment: order shall ship within 8-10 weeks after **MRC's** receipt and acceptance of your PURCHASE ORDER, signed quotation and color selections. Please note some products may require longer lead times. Consult with your Sales Representative for any extra lead time that may apply to your order.

RECEIPT OF GOODS: Customer is responsible for unloading and uncrating equipment from truck. Customer shall receive, unload and inspect goods upon arrival, noting any discrepancies on the Delivery Receipt prior to written acceptance of the shipment.
