

**A RESOLUTION OF THE TOWNSHIP COUNCIL OF NORTH BRUNSWICK
AUTHORIZING A PROFESSIONAL SERVICE AGREEMENT WITH
PKF O'CONNOR DAVIES
TO PROVIDE MUNICIPAL AUDITING SERVICES**

WHEREAS, the Township of North Brunswick has a need to acquire Municipal Auditing Services for calendar year 2024; and

WHEREAS, on October 2, 2023, the Township Council approved Resolution #308-10.23, authorizing the solicitation of Requests for Proposals (RFP) for said professional services; and

WHEREAS, services were anticipated to be procured in formal manner in accordance with Local Public Contracts Law N.J.S.A. 40A:11-4.1a et seq., under both a fair and open and competitive process to assure that each person and/or firm is provided an equal opportunity to respond to the RFP; and

WHEREAS, on Thursday, November 9, 2023, the Purchasing Agent received, and the Municipal Clerk witnessed, the receipt of one proposal in response to PRO24010; and

WHEREAS, the Evaluation Committee, designated to review proposals and make a recommendation, has completed the review process and included herein their Evaluation Report; and

WHEREAS, the Evaluation Committee recommends authorizing a contract with PKF O'Connor Davies (20 Commerce Drive, Suite 301, Cranford, NJ 07016) to serve as Municipal Auditor for calendar year 2024; and

WHEREAS, proposals have been reviewed and the response submitted by with PKF O'Connor Davies, LLC has been determined to be responsive under the provisions of the Local Public Contracts Law N.J.S.A. 40A:11-1 et seq. and any provisions of the revised statutes of the State of New Jersey; and

WHEREAS, it is in the best interest of the Township of North Brunswick to enter into an Agreement with PKF O'Connor Davies to serve as Municipal Auditor for calendar year 2024; and

WHEREAS, PKF O'Connor Davies shall be compensated for these services as outlined within their contract in the amount of \$75,000.00 for preparation of the FY2024 audit, exclusive of special services which shall be billed in accordance with the terms of the contract and charged to the related accounts, as certified by the Chief Financial Officer; and

WHEREAS, the Chief Financial Officer has certified that \$55,000.00 for the FY2024 audit is available in budget account 4-01-20-135-000-130, \$10,000.00 for the FY2024 audit is available in water account 4-05-55-502-000-130 and \$10,000.00 for the FY2023 audit is available in sewer account 4-07-55-502-000-130, and all other requested services shall be billed at an hourly rate and charged to the related improvement authorizations and/or the Finance-OE Financial Services budget account as certified by the Chief Financial Officer.

NOW, THEREFORE, BE IT RESOLVED on this 2nd day of January 2024, that the Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute and the Township Clerk to witness an agreement with PKF O’Connor Davies to serve as Municipal Auditor in the amount of \$75,000.00 for preparation of the FY2024 audit, exclusive of special services which shall be charged to the related accounts.

BE IT FURTHER RESOLVED notice of this action shall be published in the Home News & Tribune as required by law within 10 (ten) days after its passage.

Evaluation Report

Municipal Auditor - Request for Proposals – PRO24010

December 27, 2023

On October 2, 2023, the Township Council passed a Resolution #308-10.23 authorizing the advertisement for the receipt of proposals for Professional Services to include Municipal Auditor through a competitive contracting process. This process allows for factors other than price to be taken into consideration when awarding a contract. This process also requires that a committee be established to evaluate proposals in accordance with “weighted” criteria established prior to solicitation of proposals.

Pursuant to N.J.A.C 5:34-4.3, the Township established a three (3) person committee comprised of the following individuals:

Marrissa Heyman, Supervising Account Clerk

Joseph Maimone, Principal Account Clerk

The committee reviewed and discussed the Request for Proposal. The committee agreed to the criteria to be evaluated and the numerical weighting to be assigned to each. The established weighting criterion was as follows:
