A RESOLUTION OF THE TOWNSHIP COUNCIL OF NORTH BRUNSWICK AUTHORIZING AN AGREEMENT WITH CME ASSOCIATES TO PROVIDE WATER AND WASTEWATER CONSULTING SERVICES

WHEREAS, the Township of North Brunswick has a need to acquire Water and Wastewater Consulting Services for calendar year 2024; and

WHEREAS, on October 2, 2023, the Township Council approved Resolution #308-10.23, authorizing the solicitation of Requests for Proposals (RFP) for said professional services; and

WHEREAS, services were procured in formal manner in accordance with Local Public Contracts Law N.J.S.A. 40A:11-4.1a et seq., under both a fair and open and competitive process to assure that each person and/or firm is provided an equal opportunity to respond to the RFP; and

WHEREAS, on Thursday, November 9, 2023, the Purchasing Agent received, and the Municipal Clerk witnessed, the receipt of three proposals in response to PRO24014; and

WHEREAS, the Evaluation Committee, designated to review proposals and make a recommendation, has completed the review process and included herein their Evaluation Report; and

WHEREAS the Evaluation Committee recommends authorizing a contract with CME Associates (3141 Bordentown Avenue Parlin, NJ 08859) to provide Water and Wastewater Consulting Services; and

WHEREAS, proposals have been reviewed and the response submitted by CME Associates has been determined to be responsive under the provisions of the Local Public Contracts Law N.J.S.A. 40A:11-1 et seq. and any provisions of the revised statutes of the State of New Jersey; and

WHEREAS, it is in the best interest of the Township of North Brunswick to enter into an agreement with CME Associates to provide Water and Wastewater Consulting Services for calendar year 2024; and

WHEREAS, CME Associates shall be compensated for these services and reimbursable expenses as described within the contract for a total authorization not-to-exceed \$60,000.00 for calendar year 2024; and

WHEREAS, the Chief Financial Officer has certified that \$20,000.00 is available for this purpose in the Water Utility account 4-05-55-502-000-200 and \$20,000.00 is available for this purpose in the Wastewater Utility account 4-07-55-502-000-200 for services ending June 30, 2024 and the balance of funds shall be certified upon the appropriation of funds in FY2025.

EVALUATION REPORT WATER/WASTEWATER CONSULTING SERVICES REQUEST FOR PROPOSAL PRO23014 DECEMBER 29, 2022

The Township of North Brunswick seeks a qualified vendor to provide water/wastewater consulting services for the municipality in 2023. Three (3) proposals were received, all demonstrating general experience and meeting the fundamental qualifications of the services required. A three-person committee evaluated the proposals comprised of the following individuals:

Steven Bloyed, Superintendent of Sewer Salvatore Georgianna Supervisor Sewer Division Eric Chaszar, Director of Public Works

In addition to the committee reviewing proposals, Legal Counsel was engaged to reviewed proposals submitted for legal compliance.

Each committee member assessed their own affiliations and financial interest, as well as the affiliations and financial interests of family members, to ensure that there was no conflict of interest with vendors in the field. Each member signed a statement attesting to the fact that there was no conflict of interest.

The committee reviewed the Request for Proposal and alternative evaluation criteria. The committee agreed to the criteria to be evaluated and the numerical weighting to be assigned to each. The established weighting criterion was as follows:

1. Respondent's understanding and prior experience with Township -30 points

2. Experience and Qualifications of Individuals or Team -20 points

3. Respondents overall company history and Experience -30 points

4. Pricing Model - 20 points

On October 11, 2022, the Township Council passed resolution #298-10.22 authorizing the solicitation of proposals for said service. Three (3) proposals were received by the submission deadline of November 10, 2022:

In review the criteria for understanding and experience with North Brunswick, CME Associates demonstrated a good understanding of the services requested and rated the highest overall with a score of 284 points. T&M Associates ranked second with 204 points overall and Carroll Engineering scored 175 points.

As a result of its evaluation on December 29, 2022, the committee recommended that CME Associates be awarded the contract based upon overall scoring on the criteria established and review of the proposal.
