

**A RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK
AUTHORIZING AWARD OF A CONTRACT TO
SHI INTERNATIONAL FOR
SPATIAL DATA LOGIC CLOUD HOSTING SERVICES**

WHEREAS, in 2010 the Township authorized the purchase of Spatial Data Logic, a software for Community Development to upgrade to a unified system with additional interactive features including a resident web portal, GIS integration and document retrieval capabilities; and

WHEREAS, since then, several other departments including Public Works, Tax Assessor and the Municipal Clerk, have begun to utilize the software, SDL for various facets within their departments; and

WHEREAS, cloud hosting is a type of web hosting that allows software applications to be hosted on a network of interconnected servers, known as the cloud rather than hosting on a single physical server; and

WHEREAS, the Township's physical servers need an upgrade sometime in the near future, and cloud hosting this software, which is widely used throughout most Township departments, will eliminate a portion of a server to be upgraded; and

WHEREAS, utilizing cloud hosting for SDL will enable public works to have remote access for staff to enter, as well as during OEM events an avenue to both share and capture data; and

WHEREAS, SHI International, with offices located at 290 Davidson Avenue Somerset, NJ 08873, has submitted a one-year proposal for SDL cloud hosting services in the amount of \$26,200.00; and

WHEREAS, SHI International is an approved vendor under the current Cooperative Pricing Agreement with the New Jersey Cooperative Purchasing Alliance # CK04 Contract # 22-24 for Computer Equipment and Peripherals, and;

NOW, THEREFORE, BE IT RESOLVED on this 5th day of February 2024, that the Township Council of the Township of North Brunswick does hereby authorize a contract with

SHI International for SDL cloud hosting with a not-to-exceed amount of \$26,200.00, in accordance with the New Jersey Cooperative Purchasing Alliance # CK04 Contract #22-24.
