

**A RESOLUTION AUTHORIZING ACCEPTANCE AND UTILIZATION OF  
COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FUNDS –  
\$119,714.00 FOR PROGRAM YEAR 2023**

**WHEREAS**, the Township Council of the Township of North Brunswick received notice, from the office of Middlesex County Housing and Community Development, of a Community Development Block Grant (CDBG) prospective budget for program year 2023 in the amount of \$119,714.00; and

**WHEREAS**, the Middlesex County Housing and Community Development office has recommended that the allocation for the program year 2023 Consolidation Plan be proposed in the amount of \$119,714.00 and be utilized for the Code Enforcement Property Maintenance Program, Babbage Park Improvements, and Senior Center Services for the fiscal year July 1, 2023 – June 30, 2024; and

**WHEREAS**, the North Brunswick Citizens Advisory Committee held a public hearing on February 22, 2023 to approve and recommend the allocation of project proposals; and

**WHEREAS**, should the United States HUD increase or further decrease allocations to the Community Development Block Grant Program for the program year 2023, the increase or decrease should be allocated to the Code Enforcement Program;

**NOW THEREFORE BE IT RESOLVED**, on the 5th day of February, 2024, by the Township Council of the Township of North Brunswick, that the use of CDBG funds are hereby approved in accordance with North Brunswick Community Development Block Grant Non-Discretionary Allocation Requests and the recommendation of the North Brunswick Citizens Advisory Committee as follows:

Code Enforcement Salary Reimbursement:	\$ 40,000.00
Babbage Park Improvements:	\$ 68,714.00
Senior Citizen Services:	\$ 10,000.00
Code Enforcement/Public Facility Increase:	\$ 1,000.00
