WHEREAS, the Department of Public Works - Parks Division provides for pond maintenance of Hidden Lake Pond and Boyd's Pond; and

WHEREAS, a pond bubbler is a device that helps to aerate a pond by adding oxygen to the water; and

WHEREAS, at the Director of Public Work's recommendation proposals to be solicited for the purchase of two (2) pond aerators and one (1) quote was received on January 4, 2024; and

WHEREAS, the quote was submitted by Tigris Aquatic Services LLC, formally known as Black Lagoon Pond Management (PO Box 9031 Hamilton, NJ 08650) in the amount of \$20,469.11 for two (2) pond fountains; \$11,547.59 for one (1) pond aerator for Hidden Lake Pond and \$8,921.52 one (1) pond aerator for Boyd's Pond; that was determined to be both responsive and responsible; and

NOW THEREFORE, BE IT RESOLVED, that the formal quote submitted by Tigris Aquatic Services LLC is hereby accepted.

BE IT FURTHER RESOLVED, on 5th day of February 2024, that the Township Council of the Township of North Brunswick does hereby acknowledge and authorize the execution of contract PRO23075, awarded to Tigris Aquatic Services LLC, for the purchase of two (2) pond fountains in the amount of \$20,469.11.
