

Section 387-3 "Requirements for person who keep or harbor dogs/cats."

License and registration is required for any home harboring a dog(s) or cat(s) in the Township of North Brunswick due January 31, 2024.

A late fee of \$5.00 per month will be imposed beginning February 1st for each unlicensed animal.
