A RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK AUTHORIZING AWARD OF CONTRACT BID22006 TO SPINIELLO COMPANIES FOR THE OLD GEORGES ROAD WATER MAIN REHABILITATION PROJECT

WHEREAS, the Township is the owner of the Water Treatment Plant and Distribution System which includes water lines that conveys "potable" water to its customers; and

WHEREAS, rehabilitation is needed for a section of the existing 12" cast iron water main that runs under Old Georges Road off Route 130; and

WHEREAS, the scope of work consists of rehabilitation of the existing water main along Old Georges Road from the intersection of Route 130 to the intersection of Wood Avenue and includes cleaning and lining of approximately 6,622 linear feet of the 12" main, the replacement of approximately 74 linear feet of 6" water main, 117 linear feet of 8" water main, 35 linear feet of 10" water main and 391 linear feet of 12" water main in addition to fire hydrants, valves and service lines along the main; and

WHEREAS, following this project completion Middlesex County will have this segment of road scheduled for pavement resurfacing as a county road project; and

WHEREAS, the Township made application and has obtained funding approval through the New Jersey I-Bank Program; and

WHEREAS, in February of 2020, pursuant to Resolution 75-2.20, CME Associates was engaged provide survey, design and permitting through bid phase services for rehabilitation of the water line; and

WHEREAS, in August of 2022, pursuant to Resolution 247-8.22, CME Associates was engaged for services associated with the construction phase of said project; and

WHEREAS, in July of 2023, pursuant to Resolution 235-7.23, the Township solicited for receipt the of bids under a formal competitive bid process pursuant to Local Public Contract Law N.J.S.A. 40A:11-3 et seq. for the Old Georges Road Water Project, BID22006; and

WHEREAS, the Municipal Clerk witnessed the receipt of seven bids on September 6, 2023 and the lowest qualifying bid was submitted by Spiniello Companies of Livingston, New Jersey with a base bid of \$4,383,300.00 for Items 1 through 69 inclusive; and

WHEREAS, CME Associates, Engineers for this project, the Purchasing Agent and Legal Counsel have reviewed the qualifications and bid submitted by Spiniello and determined them responsive under the provisions of the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) and all other provisions of the revised statutes of the State of New Jersey, noting a curable bid irregularity that resulted in no change to the base bid.

NOW THEREFORE, BE IT RESOLVED, that the bid submitted by Spiniello Companies is hereby accepted.

BE IT FURTHER RESOLVED, Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute and Township Clerk to witness an agreement with Spiniello Companies for the Old Georges Road Water Project, pursuant to Contract, BID22006, in the amount of \$4,383,300.00 for Items 1 through 69 inclusive, subject approvals by the New Jersey I-Bank Program.

On September 6, 2023 seven (7) bids were received for the Old Georges Road Water Distribution System Improvements Project as indicated on the attached summary of bids.

The apparent low bid was submitted by Spiniello Companies of Livingston, New Jersey with a bid of \$4,383,300.00 for items 1 through 69 inclusive. The second lowest bid was submitted by Dewcon Inc. of Basking Ridge, New Jersey.

The apparent low bid submitted by Spiniello Companies contained an irregularity in that the bid docment was not submitted intact.

CME and its personnel have provided construction oversight services on previous projects which Spiniello Companies was the General Contractor. Based on our experience, it is our opinion that Spiniello Companies is capable of performing the work required by this contract.

It is our understanding that the apparent low bid is within the available funding for the Project. Accordingly, should the aforementioned irregularities be deemed curable and should there be no other irregularities in the apparent low bid as determined by the Township Attorney, we recommend award of the Project to Spiniello Companies for the total bid amount for items 1 through 69 inclusive in the amount of \$4,383,300.00, subject to written approval from the New Jersey Infrastructure Bank, certification of funds by the Township's Chief Financial Officer, review and approval by the Township Attorney including verification that the bonding and surety company is licensed to do
