## A RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK AUTHORIZING AN AMENDMENT TO CONTRACT BID20003 WITH MUNICIPAL MAINTENANCE COMPANY UNDER THE DEPARTMENT OF PUBLIC WORKS SEWER DIVISION FOR MAINTENANCE AND REPAIR OF SEWER LIFT STATIONS

**WHEREAS,** the Department of Public Works Sewer Division is responsible for providing maintenance and repairs to the municipal sanitary system; and

**WHEREAS**, in April of 2020, pursuant to Resolution 126-4.20, the Township authorized a contract with Municipal Maintenance Company (with offices at 1352 Taylors Lane, Cinnaminson, NJ 08077) to provide maintenance and repairs to municipal sewer lift stations, on an as-needed basis, for a total contract authorization of \$175,000.00, with a two-year term beginning May 1, 2020 and ending April 30, 2022, and included the option for two additional one-year extensions; and

WHEREAS, on April 11, 2022, pursuant to Resolution #130-4.22 the Township Council authorized an amendment to the agreement Municipal Maintenance extending the contract term by one year, from May 1, 2022 – April 30, 2023, for maintenance and repairs to municipal sewer lift stations, on an as-needed basis, with an increase of \$75,000.00 in the current authorization, for a revised amount of \$250,000.00; and

WHEREAS, on June 27, 2022, pursuant to Resolution #197-6.22, the Township Council authorized an amendment to the contract with an increase of \$75,000.00 in the current authorization, for a revised amount of \$325,000.00; and

WHEREAS, on September 6, 2022, pursuant to Resolution #263-9.22, the Township Council authorized an amendment to the contract with an increase of \$40,000.00 to the current authorization, for a revised amount of \$365,000.00; and

**WHEREAS**, on April 17, 2023, pursuant to Resolution #134-4.23, the Township Council authorized an extension to the contract with Municipal Maintenance for another year, with a revised contract amount of \$440,000.00; and

WHEREAS, on May 15, 2023, pursuant to Resolution #155-5.23, the Township Council authorized an amendment to the contract with an increase of \$75,000.00 in the current authorization, for a revised amount of \$585,000.00; and

WHEREAS, on September 5, 2023, pursuant to Resolution #267-9.23, the Township Council authorized an amendment to the contract with an increase of \$35,000.00 in the current authorization, for a revised amount of \$620,000.00; and

**WHEREAS**, on February 5, 2024 pursuant to Resolution #68-2.24, the Township Council authorized an amendment to the contract with an increase of \$30,000.00 in the current authorization, for a revised amount of \$650,000.00; and

Resolution :

WHEREAS, due to the submission of late invoices of work done with the contract term, Steve Bloyed, Director of the Department of Public Works, recommends authorizing an increase of \$10,000.00 to the current authorization, for a revised authorization amount of \$660,000.00; and

**WHEREAS**, the Chief Financial Officer has certified that \$30,000.00 is available for this purpose in FY2024 Sewer Operating Account 4-07-55-502-000-183 for services ending June 30, 2024; and

**NOW, THEREFORE, BE IT RESOLVED,** on this 24<sup>th</sup> day of June 2024 that the Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute and the Township Clerk to witness an amendment to the agreement Municipal Maintenance for maintenance and repairs to municipal sewer lift stations, on an as-needed basis, with an increase of \$10,000.00 in the current authorization, for a revised amount of \$660,000.00, pursuant to contract BID20003.
