

**A RESOLUTION AUTHORIZING OF THE TOWNSHIP OF NORTH BRUNSWICK  
AUTORIZING THE AMENDMENT OF CONTRACT BID22003  
WITH NATIONAL WATER MAIN CLEANING COMPANY  
FOR MANHOLE REHABILITATION SERVICES  
UNDER THE DEPARTMENT OF PUBLIC WORKS SEWER DIVISION**

**WHEREAS**, the Department of Public Works Sewer Division is responsible for providing maintenance and repairs of the municipal sanitary sewer system; and

**WHEREAS**, it is hereby the Director's recommendation to solicit and receive bids for Manhole Rehabilitation Services; and

**WHEREAS**, in February of 2022, pursuant to Resolution 68-2.22, the Township authorized a contract with National Water Main Cleaning Co. (1806 Newark Turnpike Kearney, NJ 07032) to provide Manhole Rehabilitation services, on an as-needed basis, in the amount of \$204,500.00, for estimated quantity items 1-11, with a two-year term beginning February 1, 2022 and ending January 31, 2024, and included the option for two (2) additional one-year extensions; and

**WHEREAS**, Steven Bloyed, Director of the Department of Public Works, determined there is a continued need to have a third-party company available to provide Manhole Rehabilitation services and recommends authorizing a one-year extension with no increase in the current contract amount of \$204,500.00; and

**WHEREAS**, the Chief Financial Officer has certified that \$50,000.00 is available for this purpose in FY2024 Sewer Operating – Maintenance and Repair Account 4-07-55-502-000-183 for services ending June 30, 2024 and the balance shall be certified upon the appropriation of funding in future fiscal years.

**NOW, THEREFORE, BE IT RESOLVED**, on this 4<sup>th</sup> day of March 2024 that the Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute and the Township Clerk to witness an amendment to the agreement National Water Main Cleaning Co. extending the contract term by one year, from February 1, 2024 – January 31, 2025, for Manhole Rehabilitation Services, with no increase in the current authorization amount of \$204,500.00, pursuant to contract BID22003.
