

**A RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK AUTHORIZING
AWARD OF CONTRACT BID24013 TO GIANOTTO ELECTRICAL CONTRACTING,
LLC FOR PROVISION OF ELECTRICIAN SERVICES**

WHEREAS, the Department of Public Works provides for the maintenance and repair of all Township grounds and facilities; and

WHEREAS, the Director of Public Works requested that a licensed electrician be retained to perform electrical repairs, maintenance, and installations at facilities; and

WHEREAS, on September 16, 2024 the Township Council approved Resolution 283-9.24 authorizing advertisement for receipt of bids for the Provision of Licensed Electrician Services, BID24013; and

WHEREAS, the Purchasing Agent received and the Municipal Clerk witnessed the receipt of two (2) bids on October 8, 2024; and

WHEREAS, lowest bid received was submitted by Gianotto Electrical Contracting, LLC (242 Georgetown Road, Columbus, NJ 08022) which included hourly Journeyman and Apprentice rates; and

WHEREAS, Ron Gordon with Rainone Coughlin Minchello LLC, appointed Municipal Legal Counsel, has reviewed the bid submitted by Gianotto Electrical Contracting, LLC and determined them responsive under the provisions of the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) and all other provisions of the revised statutes of the State of New Jersey; and

WHEREAS, it is the Director's recommendation to authorize a contract with Gianotto Electrical Contracting, LLC under BID24013, for the Provision of Licensed Electrician Services, that includes a two-year term beginning October 21, 2024, plus the option of two (2) one-year renewals, and an amount not-to-exceed \$50,000.00; and

NOW THEREFORE, BE IT RESOLVED, that the bid submitted by Gianotto Electrical Contracting, LLC is hereby accepted.

BE IT FURTHER RESOLVED, on this 21st day of October 2024 that the Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute and the Township Clerk to witness an agreement with Gianotto Electrical Contracting, LLC for the Provision of Licensed Electrician Services, pursuant to contract BID4013, in an amount not-to-exceed \$50,000.00, with a two-year term (October 21, 2024 – September 30, 2026) reserving the option for two (2) additional one-year terms.
