A RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK AUTHORIZING AWARD OF A CONTRACT TO SHI INTERNATIONAL FOR GPS TRACKING SOFTWARE ON MUNICIPAL VEHICLES

WHEREAS, the Township of North Brunswick maintains a fleet of vehicles across the various departments;

WHEREAS, the Township Council approved resolutions authorizing contacts with Software House International (SHI International) to provide services for a Global Positioning System (GPS) Tracking System for various vehicles, along with installation, training and internet-bases real-time fleet tracking and management software at a per unit (vehicle) cost per the following:

- Resolution #189-6.15 for a period of three years not-to-exceed \$120,000.00; and
- → Resolution #210-8.19 for a period of one year not-to-exceed \$24,000.00; and
- Resolution #210-8.20 for a period of one year not-to-exceed \$26,000.00; and
- → Resolution #228-8.21 for a period of one year not-to-exceed \$30,000.00; and
- Resolution #230-8.22 for a period of one year not-to-exceed \$30,000.00; and
- → Resolution #227-7.23 for a period of one year not-to-exceed \$32,000.00.

WHEREAS, due to the success and use of the GPS Tracking System, Director of Public Works Steve Bloyed hereby recommends to the Governing Body entering into a new contract with SHI International for GPS Tracking; and

WHEREAS, SHI International, with offices located at 290 Davidson Avenue Somerset, NJ 08873, has submitted a one-year proposal for internet-bases real-time fleet tracking and management software at a per vehicle price of \$28.50/month for ninety-four (94) vehicles, for a total amount of \$32,148.00; and

WHEREAS, SHI International is an approved vendor under the current Cooperative Pricing Agreement with the New Jersey Cooperative Purchasing Alliance # CK04 Contract # 22-24 for Computer Equipment and Peripherals, and;
