

A RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK AUTHORIZING AN AGREEMENT WITH COMMERCIAL INTERIORS DIRECT FOR THE TILING OF THE LOCKER ROOM FACILITIES IN THE POLICE DEPARTMENT

WHEREAS, Hurricane Ida impacted New Jersey on Wednesday, September 1, 2021, bringing severe weather conditions including strong winds, and heavy and sustained rainfall in some areas; and

WHEREAS, the storm caused severe damage to municipal facilities, infrastructure, and equipment, including catastrophic water damage to the basement of the Municipal Complex where the Police Department's locker room facilities were located; and

WHEREAS, Commercial Interiors Direct, 1 South Corporate Drive, Suite E, Riverdale, NJ 07457, is an approved vendor under the current Cooperative Pricing Agreement with the Hunterdon County Educational Services Commission HCESC Bid #215 for Commercial Floor Covering and Related Services; and

WHEREAS, Commercial Interiors Direct, under Bid #215, has provided a proposal to furnish and install tiles for the shower facilities in the Police Department at a price of \$81,690.54.

NOW THEREFORE BE IT RESOLVED, that the Township Council of the Township of North Brunswick does hereby authorize the award of a contract with Commercial Interiors Direct for \$81,690.54 to furnish and install tiles for the shower facilities in the Police Department.

BE IT FURTHER RESOLVED, that the Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute and the Township Clerk to witness an agreement with Commercial Interiors Direct in accordance with the previously approved Hunterdon County Educational Services Commission HCESC Bid #215.
