

**RESOLUTION AUTHORIZING THE RENEWAL OF LIQUOR

**NOW, THEREFORE, BE IT RESOLVED** on this 29th day of July, 2024, by the Township Council of the Township of North Brunswick that the Plenary Retail Distribution Licenses for NEST NB LLC, is hereby approved pursuant to the terms of AO 2024-03. The Municipal Clerk is authorized to issue Alcoholic Beverage Licenses therefore upon proper filing and full payment of the license fee provided by ordinance.
