A RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK AUTHORIZING CHANGE ORDER NO. 1 WITH SPINIELLO COMPANIES FOR THE OLD GEORGES ROAD WATER DISTRIBUTION SYSTEM IMPROVEMENTS PROJECT TO AMMEND THE CONTRACT SCOPE FROM CLEANING AND LINING OF THE EXISTING WATER MAIN TO REPLACING THE WATER MAIN IN ITS ENTIRETY

WHEREAS, the Department of Community Development is responsible oversight of the Old Georges Road Water Distribution System Improvements Project; and

WHEREAS, pursuant to Resolution 300-9.23, adopted September 18, 2023, the Township Council authorized a contract (the "Contract") with Spiniello Companies for the Old Georges Road Water Distribution System Improvements Project, under Contract BID22006, in the amount of \$4,383,300.00 for items 1 through 69; and

WHEREAS, CME Associates has recommended a modification (Change Order No. 1) to the Old Georges Road Water Distribution System Improvements Project; and

WHEREAS, the Director of Community Development, Michael Hritz, has determined the request consists of a Contract scope change from the cleaning and lining of the existing water main to the replacement with new water main; and

WHEREAS, Spiniello Companies has contracted with an engineering firm, Navier Engineering, LLC, who prepared signed and sealed plans for the water main replacement scope which were reviewed by the NJDEP Bureau of Water System Engineering who subsequently issued a construction permit dated August 26, 2024; and

WHEREAS, there is no change to the contract amount of \$4,383,300.00; the date for final completion has been changed from August 15, 2024 to December 31, 2024 to accommodate this change order; and

WHERAS, the Director of Community Development, Michael Hritz, along with CME Associates, have reviewed the request and documents submitted and have recommended that the modification (Change Order No. 1) the Old Georges Road Water Distribution System Improvements Project be approved;

NOW, THEREFORE, BE IT RESOLVED, that the Township Council of the Township of North Brunswick does hereby authorize the Mayor or Business Administrator to execute Change Order No. 1 with Spiniello Companies under the Old Georges Road Water Distribution System Improvements Project, Contract BID22006, at no additional cost and a change to the contract time of completion.

BE IT FURTHER RESOLVED, Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute, and Township Clerk to witness, an agreement with Spiniello Companies for the extension of the contract time for the Old Georges Road Water Distribution System Improvements Project, subject to the approval under the New Jersey Department of Environmental Protection (NJDEP).
