

**ORDINANCE - 2024**

**ORDINANCE OF THE TOWNSHIP OF NORTH BRUNSWICK  
AMENDING THE CODE OF THE TOWNSHIP OF NORTH BRUNSWICK  
CHAPTER 311, ENTITLED "TAXI CABS"  
SECTION 311-11, ENTITLED "INSURANCE REQUIREMENTS"  
TO COMPLY WITH RECENT AMENDMENTS TO N.J.S.A. 48:16-3**

**WHEREAS**, the New Jersey Legislature adopted amendments to N.J.S.A. 48:16-3 to increase the insurance requirements for commercial vehicles including taxis to \$1,500,000.00 and

**WHEREAS**, the New Jersey Legislature adopted S-2841 on January 8, 2024, to have an effective date of July 1, 2024, which increased the insurance requirements to \$1,500,000.00; and

**WHEREAS**, it is necessary to amend the Code of the Township of North Brunswick, Chapter 311, entitled "Taxi Cabs," Section 311-11, entitled "Insurance Requirements," to comply with the amendments of N.J.S.A. 48:16-3; and

**NOW, THEREFORE, BE IT ORDAINED**, by the Township Council of the Township of North Brunswick, County of Middlesex, State of New Jersey, that the Code of the Township of North Brunswick, Chapter 311, entitled "Taxi Cabs," Section 311-11, entitled "Insurance Requirements," is hereby amended to comply with recent amendments to N.J.S.A. 48-16.3 to require a minimum of \$1,500,000.00 in insurance coverage for taxis in the Township of North Brunswick.

**BE IT FURTHER ORDAINED**, that if any section, paragraph, subsection, clause or provision of this Ordinance shall be adjudged by the courts to be invalid, such adjudication shall apply only to the section, paragraph, subsection, clause or provision so adjudicated, and the remainder of the Ordinance shall be deemed valid and effective.

**BE IT FURTHER ORDAINED**, that any ordinances or parts thereof in conflict with the provisions of this Ordinance are repealed to the extent of such conflict.

**BE IT FURTHER ORDAINED**, this Ordinance shall take effect upon passage and publication in accordance with applicable law.
