A RESOLUTION OF THE TOWNSHIP COUNCIL OF NORTH BRUNSWICK AUTHORIZING AN AMENDMENT TO THE AGREEMENT PRO24050 WITH WILLSCOT MOBILE MINI FOR TEMPORARY FACILIITES

WHEREAS, Hurricane Ida impacted New Jersey on Wednesday, September 1, 2021, bringing severe weather conditions including strong winds, reports of tornadoes, and heavy and sustained rainfall in some areas; and

WHEREAS, the storm caused severe damage to municipal facilities, infrastructure, and equipment, including the Municipal Complex which housed municipal operations including 9-1-1 Dispatch, Public Safety, the Municipal Court, and the Municipal Clerk's Office, and

WHEREAS, in May of 2024, pursuant to Resolution 196-6.24, the Township authorized a \$165,000.00 contract with Willscot Mobile Mini (with offices at 4646 E. Van Buren Street, Suite 400, Phoenix, AZ 85008) for the monthly rental of eight mobile trailers essential to maintaining the operation of 9-1-1 Dispatch and Public Safety on an emergency basis, pursuant to the provisions of N.J.S.A. 40A:11-6(a); and

WHEREAS, Steve Bloyed, Director of the Department of Public Works, was recently made aware of three blackwater tanks attached to the trailer units which have been unbilled since the contract with Willscot was transferred to the Township on June 1, 2024; and

WHEREAS, based on calculations, there is approximately \$40,000.00 worth of expenses related to these blackwater tanks that are expected to be incurred through December 31, 2024; and

WHEREAS, Mr. Bloyed has recommended increasing the contract amount from \$165,000.00 to \$205,000.00, accounting for a net increase of \$40,000.00; and

WHEREAS, certification of the availability of funds has been provided herein by the Chief Financial Officer in accordance with New Jersey Administrative Code, Title 5-Community Affairs under N.J.A.C. 5:30-5.5; and

NOW THEREFORE BE IT RESOLVED, on this 4^h day of November 2024, that the Township Council of the Township of North Brunswick does hereby authorize an amendment to the agreement with Willscot Mobile Mini increasing the current authorization amount from \$165,000.00 to \$205,000.00, a net increase of \$40,000.00, pursuant to contract PRO24050.
