**WHEREAS**, a quote submitted by Kromer Company (2415 West Industrial Boulevard, Bay 1, Long Lake, MN 55356) in the amount of \$26,120.00 for one (1) paint machine was determined to be both responsive and responsible; and

**NOW THEREFORE, BE IT RESOLVED**, that the formal quote submitted by Kromer Company is hereby accepted.

**BE IT FURTHER RESOLVED**, on 15<sup>th</sup> day of April 2024, that the Township Council of the Township of North Brunswick does hereby acknowledge and authorize the execution of contract PRO24037, awarded to Kromer Company, for the purchase of one (1) paint machine in the amount of \$26,120.00.
