

A RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK AUTHORIZING AN AGREEMENT WITH STORR TRACTOR COMPANY FOR THE PURCHASE OF ONE GROUNDSMASTER 4100-D (T4) UNDER ESCNJ CONTRACT

WHEREAS, the Township of North Brunswick's Parks Department is responsible for the maintenance and upkeep of dozens of parks and athletic fields; and

WHEREAS, the Parks Department requires a new Groundsmaster 4100-D mower to replace an aging mower; and

WHEREAS, the Township of North Brunswick is currently a member of the Educational Services Commission of New Jersey State approved Co-op #65MCESCCPS; and

WHEREAS, Storr Tractor Company, 3191 US 22, Branchburg, NJ 08876, is an approved vendor under Educational Services Commission of New Jersey Co-Op Bid #22/23-12 for Grounds Equipment; and

WHEREAS, Storr Tractor Company, under Bid #22/23-12 has provided a proposal to provide a new Groundsmaster 4100-D with accessories, at a total cost of \$82,071.84.

NOW THEREFORE BE IT RESOLVED, that the Township Council of the Township of North Brunswick does hereby authorize the award of a contract with Storr Tractor Company for \$82,071.84 for a new Groundsmaster 4100-D with accessories.

BE IT FURTHER RESOLVED, that the Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute and the Township Clerk to witness an agreement with Storr Tractor Company in accordance with the previously approved Educational Services Commission of New Jersey Co-Op Bid #22/23-12.
