SFY24 POP-UP PARTY PREVENTION & RESPONSE INITIATIVE
STATE FISCAL YEAR 2024 and SUBAWARD NO: 24-PPP-06

WHEREAS, the Township of North Brunswick (Subrecipient) is authorized to accept the grant Subaward No: 24-PPP-06 in the amount of \$49,105.53 with a match amount of \$7.80 for a total project amount of: \$49,113.33 under the **SFY24 Pop-Up Party Prevention & Response Initiative Grant Program**, State Fiscal Year 2024, Subaward Period: May 24, 2024 to September 30, 2024; and

WHEREAS, the Township of North Brunswick has reviewed the accompanying application and has approved said requests; and

WHEREAS, this project is a joint effort between the New Jersey Department of Law and Public Safety, Office of the Attorney General and the North Brunswick Township Police Department for the purpose described in the application.
