## A RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK AUTHORIZING A SHARED SERVICE AGREEMENT WITH FREEHOLD TOWNSHIP FOR INFORMATION TECHNOLOGY CONSULTING SERVICES

**WHEREAS**, pursuant to the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1 et seq. local units of government may enter into shared services agreements to provide services that each municipality is authorized to provide; and

WHEREAS, a cooperative agreement between municipalities to share services would be beneficial to taxpayers in both local units; and

**WHEREAS**, North Brunswick requires Information Technology (IT) consulting services to supplement its internal IT department, to modernize its IT infrastructure, and to manage ongoing projects; and

**WHEREAS**, Freehold has the capacity to provide IT consulting services to North Brunswick in the areas of Level I Basic Support, Level II Networking Support, Level III Project Support, and Level IV Emergency Support; and

**WHEREAS**, both municipalities recognize that a shared services agreement will benefit taxpayers by providing more efficient and cost-effective services; and

**WHEREAS**, the Township of Freehold offers IT consulting services to public entities that encompass the following as determined necessary:

- Level I Basic Support: setup of new PC's, troubleshoot/repair hardware, help desk support
- Level II Networking Support: Network, router, firewall maintenance
- Level III Project Support: Planning, design, development of network or system infrastructure
- Level IV Emergency Support: Emergency response and support situations; and

**WHEREAS,** Administration along with the IT Department are currently exploring the optimal combination of services from Freehold Township that will expedite the implementation of the Township's IT goals.

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Council of the Township of North Brunswick, County of Middlesex and State of New Jersey, that it hereby authorizes and approves a Shared Services Agreement between the Township of North Brunswick and the Freehold Township for aforesaid services; and

**BE IT FURTHER RESOLVED,** a form of Shared Services Agreement shall be prepared and same shall be reviewed and approved by the Township Attorney for North Brunswick.
