

**RESOLUTION  
OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF NORTH BRUNSWICK  
CANCELLING THE FORFEITURE OF TAXI OWNER LICENSE NUMBERS 1, 3, 8, 13,  
17, 22, and 23 PREVIOUSLY ISSUED TO MELVIS TAXI AND LICENSE NUMBER 5  
PREVIOUSLY ISSUED TO OAXACA TAXI LLC**

**WHEREAS**, the Township of North Brunswick previously issued taxi owner licenses to Melvis Taxi with Medallion Numbers, 1, 3, 8, 13, 17, 22 and 23 with the owner being Enimia Perez with an address of 420 Church Lane, North Brunswick, New Jersey 08902; and

**WHEREAS**, Melvis Taxi failed to apply for the renewal of taxi owner licenses for Medallion Numbers 1, 3, 8, 13, 17, 22 and 23 by December 31, 2023 as required for renewal of the licenses for calendar year 2024 in accordance with Chapter 311 of the Code of the Township of North Brunswick; and

**WHEREAS**, Oaxaca Taxi LLC with the owner Marian Gonzalez with an address of 85 Washington Street, South River, New Jersey 08882 was previously issued taxi owner license Medallion Number 5; and

**WHEREAS**, Oaxaca Taxi LLC failed to submit an application for the renewal of the taxi owner license and medallion by December 31, 2023 in accordance with the requirements of Chapter 311 of the Code of the Township of North Brunswick, entitled "Taxi Cabs"; and

**WHEREAS**, the provisions of Chapter 311 of the Code of the Township of North Brunswick, entitled "Taxi Cabs" requires the renewal of taxi owner licenses and medallions on an annual basis on or before December 31, of the prior to the year for which the license is to be issued; and

**WHEREAS**, by Resolution 167-5.24, dated May 28, 2024, the Taxi Owner licenses and medallions issued to Melvis Taxi and Oaxaca Taxi LLC were forfeited; and

**WHEREAS**, the owners and representatives of Melvis Taxi and Oaxaca Taxi appeared before the Governing Body on September 30, 2024 to explain the difficulties and reasons for the failure to renew the owners licenses and medallions; and

**WHEREAS**, the owners and representatives of Melvis Taxi and Oaxaca Taxi agreed on the record to pay all outstanding fees and charges to have Medallions 1, 3, 13, 17, 22 and 23 totaling \$1,750.00 and mercantile fees and late charges for 2021-2022, 2023-2024 and 2024-2025 totaling \$225.00 (\$50.00 per year plus \$25.00 late charges for 3 years) and Medallion 5 outstanding fees and charges of \$250.00 and mercantile fees and charges for 2021-2022, 2023-2024, and 2024-2025 totaling \$225.00 (\$50.00 per year plus \$25.00 late charges for 3 years); for a total amount due of \$475.00; and

**WHEREAS**, the Township Council is willing to reinstate the requested licenses and medallions subject to payment of all outstanding fees and charges totaling \$2,450.00 and satisfactory completion of all other requirements including but not limited to inspection and approval of the vehicles and insurance coverage by the North Brunswick Police Department.

**NOW, THEREFORE, BE IT RESOLVED** on this \_\_\_\_\_ day of October, 2024, by the Township Council of the Township of North Brunswick that taxi owners licenses for Melvis Taxi with Medallion Numbers 1, 3, 8, 13, 17, 22 and 23 and for Oaxaca Taxi LLC with Medallion Number 5 are hereby reinstated subject to payment of all outstanding fees and charges of \$2,450.00 representing \$2,000.00 for the medallions and \$450.00 for mercantile fees and late charges and satisfactory inspection and approval by the North Brunswick Police Department of the vehicles and insurance coverage.
