

**A RESOLUTION AUTHORIZING AWARD OF CONTRACT TO STATE CONTRACT
VENDOR INSIGHT PUBLIC SECTOR INC. FOR THE PROVISION OF OPENGOV
ELECTRONIC PROCUREMENT PLATFORM**

WHEREAS, in July of 2020, the Township recognized the need to streamline its procurement process, and moved to an electronic platform that made the process more efficient and cost effective, as approved under resolution 196-7.20, authorizing a contract with Ion Wave Technologies, Inc. for an initial three-year contract for use of their electronic procurement platform;

WHEREAS, the current provider Ion Wave Technologies, Inc. was recently acquired by another software company (GTY Software Inc.) and will no longer be investing in the product line under Ion Wave, offering clients another platform under Bonfire Interactive, LTD.; and

WHEREAS, in September of 2023, the Township Council approved resolution 275-9.23 authorizing an additional one-year term and has been reviewing options for the upcoming term, additionally seeking to implement a comprehensive procurement management system to support and manage the entire procurement lifecycle, including: initial request and approval, solicitation development, advertising and response dates, evaluation committee review, and contract award and execution; and

WHEREAS, the Township of North Brunswick, pursuant to N.J.S.A. 40A:11-12a and N.J.A.C. 5:34-7.29(c), may by resolution and without advertising for bids purchase goods or services under the State of New Jersey Cooperative Purchasing Program for any State contracts entered into on behalf of the State by the Division of Purchase and Property in the Department of Treasury; and

WHEREAS, Insight Public Sector Inc., with offices located at 13755 Sunrise Valley Drive, Suite 750, Herndon, VA 20171 has been awarded New Jersey State Contract No. 20-TELE-01512; and

WHEREAS, under Contract no. 20-TELE-01512, Insight Public Sector, Inc. can provide the OpenGov electronic procurement platform for the Purchasing Department for a period of two years beginning July 1, 2024, with the option of two additional one-year extensions; and

WHEREAS, the Chief Financial Officer has certified that \$29,000 is available for this purpose in in the Information Technology OE Account 4-01-20-140-000-489 for services ending June 30, 2024, and the balance of funds shall be certified upon the appropriation of funds in future fiscal years.

NOW THEREFORE BE IT RESOLVED, on this 20th day of May 2024, that the Township Council of the Township of North Brunswick does hereby authorize an agreement with Insight Public Sector, Inc. for a two-year contract in an amount not-to-exceed \$75,000.
