

**A RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK AUTHORIZING AN AGREEMENT WITH NICKERSON NJ LLC FOR THE PURCHASE OF CASEWORK AND DISPLAY CABINETS FOR THE POLICE DEPARTMENT UNDER ESCNJ CONTRACT**

**WHEREAS**, the Township of North Brunswick's Municipal Complex sustained severe water damage during Hurricane Ida in September of 2021; and

**WHEREAS**, the Police Department requires new lab casework for their Armory and display cabinets in their Weapons Vault; and

**WHEREAS**, the Township of North Brunswick is currently a member of the Educational Services Commission of New Jersey State approved Co-op #65MCESCCPS; and

**WHEREAS**, Nickerson NJ LLC, 515 Union Avenue, Union Beach, NJ 07735, is an approved vendor under Educational Services Commission of New Jersey Co-Op Bid #22/23-08 for Furniture & Accessories; and

**WHEREAS**, Nickerson NJ LLC under Bid #22/23-08 has provided a proposal to furnish and install lab casework and display cases in the Police Department's Armory and Weapons Vault, at a total cost of \$36,740.55.

**NOW THEREFORE BE IT RESOLVED**, that the Township Council of the Township of North Brunswick does hereby authorize the award of a contract with Nickerson NJ LLC for \$36,740.55 to furnish and install lab casework and display cases in the Police Department.

**BE IT FURTHER RESOLVED**, that the Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute and the Township Clerk to witness an agreement with Nickerson NJ LLC in accordance with the previously approved Educational Services Commission of New Jersey Co-Op Bid #22/23-08.
