

**A RESOLUTION OF THE TOWNSHIP COUNCIL OF NORTH BRUNSWICK
AUTHORIZING AN AMENDMENT TO CONTRACT BID22009 WITH RIDE ROUNDRIP,
INC. FOR SENIOR TRANSPORTATION SERVICES**

WHEREAS, The Township of North Brunswick under the Department of Parks, Recreation and Community Services offers discounted transportation services to registered senior citizens of 62 years of age or over and handicapped residents, known as The Senior Transportation Program; and

WHEREAS, on August 1, 2022 the Township Council of the Township of North Brunswick approved Resolution 223-8.22 authorizing re-advertisement for the receipt of proposals for senior transportation services; and

WHEREAS, on August 25, 2022, the Purchasing Agent received, and the Municipal Clerk, witnessed the receipt of one (1) proposal submitted by Ride Roundtrip, Inc. (with offices at 441 N. 5th Street Suite 201 Philadelphia, PA 19123); and

WHEREAS, the Evaluation Committee, designated to review proposals and make a recommendation, has completed the review process and included herein an Evaluation Report detailing their review and recommendation; and

WHEREAS, the Evaluation Committee recommended the award of contract BID22009 to Ride Roundtrip, Inc. (441 N. 5th Street, Suite 201, Philadelphia, PA 19123) for senior transportation services based on their proposal of \$625/month + the cost of transportation from the transportation vendor; and

WHEREAS, on September 6, 2022, pursuant to Resolution 257-9.22, the Township Council authorized an agreement with Ride Roundtrip, Inc. (441 N. 5th Street, Suite 201, Philadelphia, PA 19123) to provide senior transportation services, with an authorization not-to-exceed \$130,000.00 and a three-year term, September 1, 2022 – August 31, 2025, with the option of two (2) one-year renewals if necessary; and

WHEREAS, due to an increase in demand in senior transportation, the Director recommends authorizing an increase of \$55,000.00 to the current authorization, for a revised authorization amount of \$185,000.00; and

NOW THEREFORE BE IT RESOLVED, on this 19th day of August 2024, that the Township Council of the Township of North Brunswick does hereby authorize an amendment to the agreement with Ride Roundtrip, Inc. to provide senior transportation services, with an increase of \$50,000.00 to the current authorization, for a revised authorization amount of \$185,000.00.
