WHEREAS, the Township of North Brunswick has a need to acquire Environmental Engineering Services for 2025; and

WHEREAS, on September 16, 2024, the Township Council approved Resolution 289-9.24, authorizing the solicitation of Requests for Proposals (RFP) for said services; and

WHEREAS, services were procured in formal manner in accordance with Local Public Contracts Law <u>N.J.S.A.</u> 40A:11-4.1a et seq., under both a fair and open and competitive process to assure that each person and/or firm is provided an equal opportunity to respond to the RFP; and

WHEREAS, on Thursday, November 14, 2024, the Purchasing Agent received, and the Municipal Clerk witnessed, the receipt of three (3) proposals in response to PRO25016; and

WHEREAS, the Evaluation Committee, designated to review proposals and make a recommendation, has completed the review process and included herein their Evaluation Report; and

WHEREAS, the Evaluation Committee recommends authorizing a contract with T&M Associates (Eleven Tindall Road, Middletown, New Jersey 07748) for Environmental Engineering Services; and

WHEREAS, proposals have been reviewed and the response submitted by T&M Associates has been determined to be responsive under the provisions of the Local Public Contracts Law <u>N.J.S.A</u>. 40A:11-1 et seq. and any provisions of the revised statutes of the State of New Jersey; and

WHEREAS, it is in the best interest of the Township of North Brunswick to enter into an agreement with T&M Associates to provide Environmental Engineering services, as requested by the Township, for calendar year 2025; and

WHEREAS, the Chief Financial Officer shall certify and appropriate funds from the budgeted and capital improvement authorizations relating to services rendered of which T&M Associates shall be compensated in accordance with the rate scheduled provided within the RFP.

NOW, THEREFORE, BE IT RESOLVED on this 2nd day of January 2025, that the Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute and the Township Clerk to witness an agreement with T&M Associates to provide Environmental Engineering services, for calendar year 2025, in accordance with RFP PRO25016.

BE IT FURTHER RESOLVED notice of this action shall be published in the Home News & Tribune as required by law within 10 (ten) days after its passage.

EVALUATION REPORT ENVIRONMENTAL ENGINEERING SERVICES - REQUEST FOR PROPOSAL DECEMBER 30, 2024

The Township of North Brunswick seeks a qualified vendor to provide Environmental Engineering services for 2025. Three (3) proposals were received, all demonstrating general experience and meeting the fundamental qualifications of the services required. A three-person committee evaluated the proposals comprised of the following individuals:

Michael C. Hritz, Director of Community Development Steve Bloyed, Director of Public Works Salvatore Profaci, Zoning Officer

Each committee member assessed their own affiliations and financial interest, as well as the affiliations and financial interests of family members, to ensure that there was no conflict of interest with vendors in the field. Each member signed a statement attesting to the fact that there was no conflict of interest.

The committee reviewed and discussed the Request for Proposal and alternative evaluation criteria. The committee agreed to the criteria to be evaluated and the numerical weighting to be assigned to each. The established weighting criterion was as follows:

- 1. Understanding and Prior Experience with the township 30 points
- 2. Experience and Qualifications of Individuals 20 points
- 3. Overall company history 30 points
- 4. Agreement to the Pricing Model -20 points

The Township Council authorized the solicitation of proposals for said service and the following three (3) proposals were received by the submission deadline:

CME Associates 3141 Bordentown Ave. Parlin, NJ 08859

Prestige Environmental, Inc. 220 Davidson Avenue, Suite 307 Somerset, NJ 08873

T&M Associates Eleven Tindall Road Middletown, NJ 07748

The committee discussed the proposals sharing observations including: experience, knowledge of professionals and other factors. The committee members then individually filled out Committee Evaluation Forms, assigning numerical scores for each firm.

T&M Associates received the highest score overall at 286 points. T&M has been highly engaged by the Township over several years in a continuing role managing the various projects within the rehabilitation of the Municipal Building since September of 2021. They have managed many projects over the past few years including the renovation of Veterans Park associated with the high school soil contamination project, improvements to the Roosevelt Avenue Extension, and the Water Main Replacement Project.

CME Associates placed second with a total of 253 points, having skilled experience and demonstrated success with environmental engineering contracts. Prestige Environmental received 218 points.

The scoring for T&M Associates is reflective of their prior engagement, responsiveness, and exceptional service to the township. Accordingly, it is the Evaluation Committee's recommendation to appoint T&M Associates as Environmental Engineer.
