

**A RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK AUTHORIZING AN AGREEMENT WITH FRANK'S TRUCK CENTER FOR THE PURCHASE OF ONE 2024 GMC 3500 SIERRA CREW CAB PICK-UP FOR THE SEWER DEPARTMENT UNDER ESCNJ CONTRACT**

**WHEREAS**, the Township of North Brunswick's Sewer Department is responsible for the maintenance and repair of all sewer lift stations; and

**WHEREAS**, the Sewer Department has expanded its workforce and requires an additional vehicle to maintain efficient operations; and

**WHEREAS**, the Township of North Brunswick is currently a member of the Educational Services Commission of New Jersey State approved Co-op #65MCESCCPS; and

**WHEREAS**, Frank's Truck Center, 325 Orient Way, Lyndhurst, NJ 07071, is an approved vendor under Educational Services Commission of New Jersey Co-Op Bid #23/24-11 for Cars, Crossovers, Class 1 – 3 Trucks/Chassis/SUV and Vans; and

**WHEREAS**, Frank's Truck Center, under Bid #23/24-11 has provided a proposal to provide a new 2024 GMC TK30743 – 3500 Sierra Crew Cab Pick-Up 4x4 with an ISA PRO package, at a total cost of \$57,994.78.

**NOW THEREFORE BE IT RESOLVED**, that the Township Council of the Township of North Brunswick does hereby authorize the award of a contract with Frank's Truck Center for \$57,994.78 for a new 2024 GMC TK30743 – 3500 Sierra Crew Cab Pick-Up 4x4 with an ISA PRO package.

**BE IT FURTHER RESOLVED**, that the Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute and the Township Clerk to witness an agreement with Frank's Truck Center in accordance with the previously approved Educational Services Commission of New Jersey Co-Op Bid #23/24-11.
