

**A RESOLUTION CONSENTING TO THE APPOINTMENT OF  
SAMANTHA LAU AS DEPUTY COURT ADMINISTRATOR FOR THE  
MUNICIPAL COURT OF THE TOWNSHIP OF NORTH BRUNSWICK**

**WHEREAS**, the North Brunswick Municipal Court Administrative Office is staffed with one Court Administrator, two Deputy Court Administrators, and three full-time Violation Clerks; and

**WHEREAS**, in May 2023, following the resignation of Kelly Wolff, Luciana Wheeler was appointed to serve as a Deputy Court Administrator for the Municipal Court of the Township of North Brunswick; and

**WHEREAS**, in October 2024, the Township received a letter of resignation from Luciana Wheeler, creating a vacancy for the position of Deputy Court Administrator, which was duly noticed in November 2024 to solicit applications from qualified candidates; and

**WHEREAS**, in December 2024, Municipal Officials collaborated with the Superior Court of New Jersey's Municipal Division Manager for the Middlesex Vicinage on the interview and selection process; and

**WHEREAS**, after the conclusion of interviews conducted by the evaluation panel, the Mayor recommended the appointment of Samantha Lau to serve as Deputy Court Administrator, a recommendation supported by the Presiding Judge, Christine Heitmann, and the Municipal Division Manager, Laura Schweitzer; and

**WHEREAS**, the Township Council supports this recommendation and wishes to consent to the appointment of Samantha Lau as Deputy Court Administrator for the Municipal Court of the Township of North Brunswick;

**NOW, THEREFORE, BE IT RESOLVED**, on this 21<sup>st</sup> day of January, 2025, that the Township Council of the Township of North Brunswick, County of Middlesex, and State of New Jersey, hereby consents to the appointment of Samantha Lau to serve as Deputy Court Administrator for the Municipal Court of the Township of North Brunswick, effective February 1, 2025.
