

**TOWNSHIP OF NORTH BRUNSWICK  
RESOLUTION 222-6.25**

**Confirming the Appointment of Jason Sheets as Municipal Tax Assessor  
for the Township of North Brunswick**

**WHEREAS**, a Municipal Tax Assessor is responsible for the assessment of real property within a municipality, with the objective of ensuring equity in the distribution of the property tax levy, which in North Brunswick supports the municipal, school, county, library, and open space levies; and

**WHEREAS**, the Township of North Brunswick has a statutory obligation to appoint a certified Municipal Tax Assessor in accordance with N.J.S.A. 40A:9-146 and N.J.S.A. 54:1-35.31; and

**WHEREAS**, the Mayor of the Township of North Brunswick desires to appoint Jason Sheets, a certified tax assessor, to the position of Municipal Tax Assessor; and

**WHEREAS**, Jason Sheets meets the qualifications required under New Jersey law and holds the Certified Tax Assessor (CTA) designation as required by the New Jersey Division of Taxation; and

**WHEREAS**, the term of appointment for a Municipal Tax Assessor is a four-year term in accordance with N.J.S.A. 40A:9-148, commencing on July 1, 2025, and ending on June 30, 2029, subject to all applicable provisions of New Jersey Statutes, Civil Service regulations, and Township ordinances.

**NOW THEREFORE, BE IT RESOLVED**, on this 23<sup>rd</sup> day of June 2025, the Township Council of the Township of North Brunswick does hereby grant its advice and consent to the Mayor's appointment of Jason Sheets to the position Tax Assessor for the Township of North Brunswick for a four-year term, effective July 1, 2025 and expiring June 30, 2029, unless otherwise provided by law; and

**BE IT FURTHER RESOLVED**, that a certified copy of this resolution shall be forwarded to Marita R. Sciarrotta, Acting Director of the New Jersey Department of the Treasury, Division of Taxation; Ryan Riccio, Tax Administrator of the Middlesex County Board of Taxation; the New Jersey Department of Community Affairs; and Jason Sheets.

This Resolution shall take effect immediately.
