

**TOWNSHIP OF NORTH BRUNSWICK
RESOLUTION 229-6.25**

**Authorizing Award of Contract Bid 25001 To Lucas Brothers, Inc. for the 2025 Road
Improvement Program**

WHEREAS, the Department of Community Development is responsible for construction and improvements of various municipal streets, roads and curbing; and

WHEREAS, in October 2024 municipal officials for the Department previously engaged municipal engineering firm CME Associates pursuant to Resolution 329-10.24 to provide design through bid phase services relating to the 2025 Road Improvement Program; and

WHEREAS, on May 19, 2025, the Township Council approved Resolution 185-5.25 authorizing advertisement for receipt of bids for 2025 Road Improvement Program, BID25001; and

WHEREAS, the Municipal Clerk witnessed the receipt of three (3) bids on June 12, 2025 and the lowest qualifying bid was submitted by Lucas Brothers, Inc. of Morganville, NJ with a base bid of \$5,905,461.75 for Items A-1 through B-179 inclusive; and

WHEREAS, CME Associates, Engineers for this project, the Purchasing Agent and Legal Counsel have reviewed the qualifications and bid submitted by Lucas Brothers, Inc. and determined them responsive under the provisions of the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) and all other provisions of the revised statutes of the State of New Jersey.

NOW THEREFORE, BE IT RESOLVED, that the bid submitted by Lucas Brothers, Inc. is hereby accepted.

BE IT FURTHER RESOLVED, Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute and Township Clerk to witness an agreement with Lucas Brothers, Inc. for the 2025 Road Improvement Program, pursuant to Contract BID25001, in the amount of \$5,905,461.75 for Items A-1 through B-179 inclusive, subject to approvals by the New Jersey Department of Transportation.
