

**TOWNSHIP OF NORTH BRUNSWICK  
RESOLUTION 281-9.25**

**Authorizing an Amendment to Contact BID22009 with Ride Roundtrip, Inc.  
for Senior Transportation Services**

**WHEREAS**, The Township of North Brunswick under the Department of Parks, Recreation and Community Services offers discounted transportation services to registered senior citizens of 62 years of age or over and handicapped residents, known as The Senior Transportation Program; and

**WHEREAS**, on August 1, 2022 the Township Council of the Township of North Brunswick approved Resolution 223-8.22 authorizing re-advertisement for the receipt of proposals for senior transportation services; and

**WHEREAS**, on August 25, 2022, the Purchasing Agent received, and the Municipal Clerk, witnessed the receipt of one (1) proposal submitted by Ride Roundtrip, Inc. (with offices at 441 N. 5<sup>th</sup> Street Suite 201 Philadelphia, PA 19123); and

**WHEREAS**, on September 6, 2022, pursuant to Resolution 257–9.22, the Township Council authorized an agreement with Ride Roundtrip, Inc. (441 N. 5<sup>th</sup> Street, Suite 201, Philadelphia, PA 19123) to provide senior transportation services, with an authorization not-to-exceed \$130,000.00 and a three-year term, September 1, 2022 – August 31, 2025, with the option of two (2) one-year renewals if necessary; and

**WHEREAS**, on August 19, 2024, pursuant to Resolution 254-8.24, the Township Council authorized an increase of \$55,000.00 to the contract authorization, for a revised authorization amount of \$185,000.000; and

**WHEREAS**, the Director of the Department of Parks, Recreation, and Community Services has recommended the Township extend contract BID22009 with Ride Roundtrip, Inc. for one additional year, changing the term of the contract to September 1, 2022 – August 31, 2026, and add an additional \$60,000.000 to the contract authorization for a revised authorization amount of \$245,000.00.

**NOW THEREFORE BE IT RESOLVED**, on this 8<sup>th</sup> day of September 2025, that the Township Council of the Township of North Brunswick does hereby authorize an amendment to the agreement with Ride Roundtrip, Inc. to provide senior transportation services to extend the contract by one year, for a revised term of September 1, 2022 – August 31, 2026 and add \$60,000.00 to the current authorization, for a revised authorization amount of \$245,000.00.
